#### **The fate of the MSS director and the new “Cheney Plan”**

Now, by the time I got kicked out of Karin's meetups on September 6 2008, the first episode of the drama of the International Court of Justice – the conviction of China – had very much come to fruition and another – the conviction of Russia – was about to begin. Through the conviction of the MSS director as a terrorist mastermind and magnificent fraudster Mr Secretary of Homeland Security and his “Boss” the Vice President would have accidentally discovered a different avenue for the establishment of their utopian *Weltstaadt* of which they had been dreaming. The new avenue was intimately tied up with their further use of the MSS director and his spy organ. This is the subject of this second Appendix.

### THE ORIGINAL CHENEY PLAN

Dick Cheney’s original plan of which the 911 attack was the starting point seems to have been something like this. With the advent of Peak Oil, Cheney began envisaging a solution in the termination and remake of humanity. The exhaustion of fossil fuel required a serious depopulation of the planet earth, and Cheney began contemplating on using the opportunity to reshape human society as well so

itself. Jesus pointed this out, citing Isaiah. This was however a challenge to the power and authority of the establishment, represented by the Pharisees and the teachers of the law. They thus wanted Jesus dead, and Jesus knew that, and could predict his own death. This is a Biblical example of how truth offends and brings disaster to its spokesperson, for the establishment almost always, throughout history, represents falsehood. As I have hinted in the Preface, I would be even more detested than I have already been for speaking the truth of my experience.

that human community would never again run into the same problem of unsustainability. Cheney believed in what Naomi Klein has termed “disaster capitalism.”<sup>3</sup> He thus planned 9/11 attack, with the goal of having a pretext under which to invade the Middle East and Central Asia, not only in order to grab up as much of the remaining oil reserves in the world as possible, but, ultimately, to provoke Russia and China into nuclear warfare with the United States so that, when United States should emerge victorious after the destruction of the rest of humanity, the neoconservatives could recreate a new humanity small enough for the planet to support with the tiny bits of resources still remaining. The Boss of neoconservatism, Cheney, had a personal stake in all this, for Peak Oil means that the production of oil must decline when more than half of the oil reserve on the planet had been used up. The global economy -- of which “oil forms the building blocks” to use the Boss’ own words -- will consequently begin shrinking and declining. All this was not good news for the energy and commercial elites for whose interests the Boss represented. They found the slow decline of world economy to be distasteful because it would destroy the power base of the political and corporate elites while human civilization disintegrated into chaos. A controlled, sudden collapse of the world's economy all at once would be preferable because, well, the process was controlled and so manipulated to preserve the power base of the elites. Presumably, after the war in Iraq had gone bad, the “Boss” was planning bombing Iran with nuclear bombs, using the pretext that Iran’s nuclear facilities were too underground for conventional bombs to strike. When the Air Force generals refused to obey, the “Boss” then planned on exploding USAF nuclear war heads on American soil itself and blaming it on terrorists hiding in Iran, thus obtaining the needed excuse to launch nuclear strikes on Iran. Cheney hoped that in this way China and Russia may be provoked to war in the Middle East. When China and Russia fell for the trap and eventually fired nuclear weapons on the United States, the United States would triumph and rise from the ashes of nuclear holocaust to dominate a world that would have thus been vastly depopulated. Big businesses like Halliburton would then take over the “project” of rebuilding a utopia out of the ruins in accordance with the model of “disaster capitalism”. This plan – which we call the “Cheney Plan” -- must have been what Michael Ledeen has referred to as the “historic mission” of the Neoconservatives.<sup>4</sup> Iran was the turning point because, insofar as Iran had become a member of the Shanghai Cooperation Organization, it was expected that China and Russia would retaliate for Iran's sake with nuclear weapons. Although even this second plan was foiled by some disobedient Air Force general who leaked it to the public in the middle of 2007, so that one couldn't say what would come

Naomi Klein traces the origin of “disaster capitalism” to the Chicago school of economics founded by Milton Friedman in the 1950s, which advocates the purest form of capitalism where, under a complete absence of regulation and complete privatization of public services, a utopia emerges where supply perfectly matches demand. Big businesses like it because they can then have their way without obstacles and care for national boundaries. Since all the so-called “free market societies” have during the twentieth century adopted a myriad of regulations and social services, the disaster capitalists regard them as corrupted and distorted, “[the] unspoken assumption from the beginning was that much of it would have to disappear, to clear the ground for the grand experiment” (p. 417 – 8). When they came to the conquered Iraq, their plan has been “the use of ultimate shock to forcibly wipe out and erase all obstacles to the construction of model corporatist states free from interference” (p. 418 - 9), a corporatist state meaning a state which contracts out all governmental services to private companies and sets a minimum of regulations. In other words, they were planning to do to the planet what they had done to Iraq, an “initial bombardment... designed to erase the canvas on which the model nation could be built” (p. 419).

after that, Iran had always remained the turning point in the “Cheney plan”, and this was probably why the UN Security Council had had to hold an emergency meeting to “discuss Iran” on January 22 2008 or so whereabouts when I flew to Germany.

The objective of provoking Russia into nuclear war explains why a missile defense system covering over the United States was so important to the neoconservative agenda, and why Russia had always known that this system was meant to intercept *its* inter-continental ballistic missiles rather than those of Iran. And the ultimate objective of all this world wars was the eventual establishment of a utopian *Weltstaadt*, under a single world government controlled by a small cadre of elites, and which would function so orderly and smoothly because microchips and nanochips would be implanted in the body and brain of every one of its citizens to cause him or her to blend completely into the whole. No one will never get out of line. The influence of Plato's *Republic* on the neoconservative thinkers here, along with the ideals of the French revolution, is clearly visible.

I am summarizing the matter very quickly here. In the Preface to Volume V I will present a more detailed exposition of the “Cheney Plan” and explain its relationship with what the conspiracy theorists have been calling the “New World Order”. In that context I will also describe Cheney’s problematic relationship with the rest of the Western elites, and then offer an outline of the utopia such as he had conceived it. Here I will simply ask you to remember the essence of the *original* Cheney Plan: originally, before my case, that is, the “Boss”, having yet the chance to get his hands on the Chinese and Russian elites, was simply planning on provoking China and Russia into a “first strike” by continually placing American troops as close to the two countries' borders as possible and by bombing their neighbors with nuclear bombs.

### THE STRATEGIC USE OF MSS DIRECTOR

It was something of this plan which the MSS director had exposed in December 2007 in the United Nations using documents obtained from the interior of the CIA. The “Boss”, deeply angered by the director of the MSS for daring to expose his plan for planetary domination – from 911 attacks to the plan to use Iran as the starting point of a nuclear warfare – had decided upon a cruelest method of revenge against him. The revenge would be packaged with the final shot of the enforcement of UN Resolution 1373.

Recall that China, and the MSS director, were obliged under UN Resolution 1373 to help United States reverse the “terrorist harm” which the MSS director and the terrorist suspect (me) had inflicted on the United States, and that this reversal eventually amounted to making China suffer everything which China (or the MSS director) had originally intended to make United States suffer and making United States gain everything which the MSS director had originally wanted to gain for China. Now that China was convicted as a terrorism-sponsoring state, there was one thing left: since the MSS director had attempted to use my case to restructure international relations in China's favor, China, and the MSS director, were now obliged to help United States restructure international relations in favor of the United States. Now how had Cheney wanted to restructure international relations in his favor? Since the original “Cheney plan” would no longer work out – everyone had seen it, and the United States had had to deceive everyone, with forged documents from the MSS, into believing that this plan was a Chinese fabrication planted inside the CIA’s “secret box” – he had devised a new plan, which China and the MSS director were therefore obliged to help him accomplish.

Let’s trace out the working of this “new Cheney Plan” step by step. Recall that Cheney’s agenda is that the world was under tremendous threat because Islamic terrorists had been supplied with nuclear bombs – by none other than the MSS director himself. He had wanted the world to buy into this imaginary threat so that US military occupation of oil rich nations – both to obtain the oil fields for its own sake and to surround China and Russia with military bases – may be justified for security reasons. After the establishment of this (imaginary) reality in the United Nations with forged MSS documents, the UN would of course, prompted by the United States, pass resolution prohibiting China’s spy organ the MSS from further operation. Cheney would then secretly order the MSS director to violate the resolution and to continue supplying Islamic terrorists with mini-nukes. But Cheney would order that the MSS do this clumsily enough so as to get caught. The MSS director would have to comply – and keep United States’ command in utmost secrecy, of course – for the United States was telling him: “You are obliged under UN Resolution 1373 to compensate us with the restructuring of international relations in our favor, thus with our global domination, and this is how we are going to restructure international relations to achieve our global dominion: through nuclear terrorist threat which you supposedly have created.” Thus, the MSS director was obliged by international laws to violate international laws. And so the MSS supplied terrorists with mini-nukes and pretended to get caught by the United States. Since nations around the world didn't know that the MSS was under US command to help America restructure international relations in its favor, they really believed that the MSS director, bad-to-the-bone, still wanted to harm the United States by supplying anti-American terrorists with nuclear bombs. Nations were shocked; and at this point Cheney could implement his plan – to be named the “new Cheney Plan” – in two directions.

First, the United States proposed in the United Nations that all government officials in the world should be microchipped under their skin. A super computer was then set up to interface with these microchips. If any official of any country violated international laws or International Court order and secretly maintained dealings with terrorist organizations, the computer would know and would send a signal to the microchip inside the official's body causing him to die. Given the gravity of the threat, all nations in the United Nations voted for a special resolution to require that this system be set up to track the movements of all government officials around the world. Although the system was American-made, presumably United States had given the guarantee that the system was automated – the computer worked by itself – so that neither American officials nor anybody else would have to sit in front of it to monitor what the microchipped officials were doing when they were not colluding with the terrorists. Everyone could still keep his or her privacy.

The second step was this. The United States DARPA (Defense Advanced Research Projects Agency) had been developing a special sort of technology of domination since a decade ago. Just when the summer came in 2008, this technology of domination finally passed all trials, and the “Boss” wanted to use it precisely on the man who, most hateful, had exposed his Plan. The technology consisted in the implantation of nanochips into the human brain so as to render the person “remotely controllable” from US government control centers. The remotely controlled person would look so natural that nobody would be able to tell he was no longer himself but was being remotely controlled to perform his actions. In fact, the remotely controlled person himself wouldn't know it unless he was told about it. Now that United States had obliged the MSS director to violate international laws and International Court order as a way to obey international laws and International Court order, Mr Secretary Chertoff would then come before the United Nations assembly and point out to them the extraordinary bad

character of MSS' man in continually ignoring international laws and International Court orders. "This man's hatred for my great country is so extreme that, after he has failed to dethrone my country through the fraudulent use of the International Court system, he still tries to arm the terrorists with nuclear bombs so as to harm us. Such a man must be a psychopath, biologically defective and requiring 'medical treatment' to right his physical defects," so would Mr Secretary say to everyone. The officials around the world, angered by the continual frauds and ignorance of international laws on the part of MSS director even after he was caught, would thus agree, and would pass another special resolution enabling the United States to build a special "medical division" right inside the International Court that would incorporate the "special sort of technology of domination" for the sake of "enforcing International Court judgments". Since a nanochip system to remotely control people as if they were your personal remotely controlled robots would be too shocking with its ability to deprive people of their free will, Boss Cheney would want to hide from nations around the world the true nature of this technology but would deceive them with the story that it was some sort of humane "anti-psychotic nanochip regiment" that was designed to calm the bad instincts of especially acute Antisocial Personality Disorder. Nations around the world now be ever more impressed by the superb humanitarianism and forgiveness practiced by United States in general and Mr Secretary of Homeland Security in particular. The global respect for the United States would have been further reinforced by the reason of "respect for citizens' privacy" which Mr Secretary had formerly presented in the International Court as a way to convince the judges to accept as evidence surveillance intercepts in which nothing could be seen and no one could be identified. Since nobody knew that the nanochip system's real function was to turn a human being into a remotely controlled robot, all nations, and all the judges of International Court, voted for the resolution to introduce into the International Court system in respect to my case the "nanochip regiment to correct Antisocial Personality Disorder".

As Mr Secretary and his Boss now planned on taking out Russia with the same techniques of faulty evidence about me in consequence of Russia's war in Georgia, they may have also decided to make further inroads into the Chinese government beyond the point of vengeance until a complete take-over of the governmental machinery of the People's Republic of China through the International Court. When the judges at the ICJ had, with Mr Secretary's "surveillance evidence", thus pronounced the judgment that MSS director should be subjected to "medical treatment" to correct his unrelenting "anti-social instincts" in "unending disregard of international laws, order, and norms," this Chinese official would be the first person to be transported into that super-secret "Chamber for the Reinforcement of Judgments" and therein, either alone or under the supervision of a "medical doctor", to have nano devices implanted in his brain. He would then walk out of the International Court and return to China, remotely controlled by Mr Secretary from his Homeland Security control center to gradually work sedition and sabotage within his own *patrie*. (Soon, of course, the Chinese president would have him removed from his official post as a supreme embarrassment to China.) Although, technically speaking, the "medical treatment of Antisocial Personality Disorder" in the International Court was for "humanitarian reasons" so secret that even the judges themselves were barred from its sight, the "Chamber" must definitely have cameras installed therein which would transport the images of the process of implantation right to the "Boss'" office, where he, supporting himself on his cane, could watch these with the satisfaction of having at last overcome a will that had dared resist with a counter bite his plan for planetary domination. The images ("videos") would then certainly have been passed around, through Mr Secretary's hands, among all the power elites of the Western alliance whom the director of the MSS had earlier offended, to work the same delight in their mind. Meanwhile, Mr Secretary would order "his robot", MSS director, to frame more officials in the Chinese government for

the same crime of “conspiracy to fake a terrorist suspect and harm the United States through the International Court system”, resulting in more officials in the Chinese government being brought to the International Court to receive “medical treatment for their Antisocial Personality Disorder”. These Chinese officials could then be sent back to the Chinese government as additional “robots” remotely controlled by the US government, today to sign this treaty obliging China to make this concession to the US, and tomorrow to do that bad thing in order to make China look bad in the international community. Gradually observers inside the Chinese government would start having a strange impression that a wild contagious disease seemed to have been spreading across the Chinese governmental machinery, altering the way in which an increasing number of them behaved themselves. United States was basically installing a series of “Manchurian candidates” inside the Chinese government.<sup>5</sup> Mr Secretary and his Boss could not however be completely successful. The fragmentary nature of the Chinese government – after MSS’ loss at the International Court, other departments of the Chinese government must have emphatically disavowed for their international audience any relationship with the main spy agency of their country – would have prevented Mr Secretary from framing and taking command of every department of it.

Mr Secretary’s vengeance toward the MSS director would not have stopped there. He must have continually remotely controlled him to engage himself in wild sexual orgies and alcoholic bouts, and even to attempt to kill people; he would then pretend to offer him help, but secretly remotely control him to refuse his help. When this was brought to attention of the United Nations, everyone would be thoroughly enraged by the devilish character of China’s spy chief and thoroughly impressed by the opposite, saintly, and forgiving character of Mr Secretary. Mr Secretary would then tell everyone – since nobody was aware that the real function of the nanochip system was to render the MSS director Americans’ remotely controlled robot – that, apparently, the regime to calm the MSS director’s anti-social instincts did not work because he suffered from schizophrenia and was hearing voices (for the nano devices inside his brain was transmitting voices to him) – just like the David Chin whom he had recruited: apparently China’s spy chief had a passion for anti-social schizophrenics because he was himself one of these creatures. Again, this was done not just for the sake of personal revenge, but had a very important strategic function, in that it had rendered nations around the world increasingly comfortable with the American proposals to chip every one of their officials as a way to force obedience to international laws and International Court order on pain of death.

And so China was becoming, throughout 2008 and 2009, increasingly an American “ally” – or “colony”, which is a better description – either through the chipping of its officials to make them Americans’ remotely controlled robots or through the concession it had to make to the United States for having attempted to arm terrorists with nuclear bombs to attack the United States. The next step in Cheney’s new plan consisted in this. With the faulty surveillance Machine wired up to the International Court and fooling the judges therein into believing that it actually said something true, Mr Secretary need only make up any story of any crimes by any nation of his choosing so as to sue a governmental portion of that nation – he would then be able to gain inroads into the entire government of that nation in the same way in which he had done with China until he should finally take over that nation’s governmental machine by force-implanting nanochips into the brains of that nation’s officials. All Mr

Secretary had to do was to frame one official therefrom – he could then force that official to frame himself and his colleagues to no end. For this to happen, the United States now proposed to the United Nations that nations around the world hand over the databases of their intelligence agencies to the newly installed, centralized computer database of the International Court – so that the faulty surveillance Machine could access them. Ostensibly, this so that the world could discover if the conspiracy to falsely sue the United States had spread any further beyond China. When every intelligence agency in the world, of every nation, had submitted its entire database to the International Court under the direct access of the faulty surveillance Machine, evidence may easily come to light as to who else was in conspiracy with me. Nations around the world were again compelled to vote for this American proposal for no one dared question the pretext of international law and order, especially when the planet was under the unprecedented threat of nuclear terrorism. Nations around the world were in effect agreeing to a sudden increase of power of the International Court in deciding their fate should any one of them ever get entangled in a lawsuit there. Since there always existed the “danger” that the representatives of a nation, feeling that they had been entangled in this lawsuit for bogus reasons, might not show up, the microchips implanted in their body would ensure that, if anyone was called to the International Court to answer the discovered charge of conspiracy, he or she could not just not show up. It is then the conviction of China, and moreover MSS director’s continual dealing with terrorists in violation of International laws, which had served the strategic function in this neoconservative project of the centralization of the world from the International Court of Justice.

Although born out of revenge, Mr Secretary's destructive wish against the Chinese governmental machine had turned into a great sense of cure of the inferiority complex which he had earlier felt vis-à-vis the CIA clandestine service: the inferiority feeling that he might not be the Master of Deception of the Planet Earth after all. He now had both the Agency and the Chinese MSS under his command and, although the MSS was inferior to the Agency, it possessed all sorts of tricks which he had never seen before. Speaking from my own experience, I have named the incredible Chinese super pickpocket whom he had constantly sent out to steal things from me. Things like that would have absolutely delighted him, for he took as the greatest joy in the world the feeling of being able to cheat, steal, and hurt people behind their back and in utter secrecy, while appearing to people in the open as just the opposite, a stern and honest enforcer of laws. Insofar as he had not much of an education and understood little of the human world – his law degree from Harvard notwithstanding – the CIA’s cultivation in culture and academia would have meant much less to him than such tricks as a super pickpocket or the secret use of underage entities to conduct clandestine operations against people he didn’t like. In fact, his normal reaction toward things which others found to be of value but which escaped his mind was to simply waste and destroy them so that he may continue to claim the throne as the most superior mind in the universe. But, as he started his “lawsuit” against Russia in September 2008 as the next step in the new Cheney plan for establishing *Weltstaadt*, he must have felt a very personal stake in it as well, in two respects. First of all, he had never cleared up his perjury charges in regard to the incident of “Zudy Pingley Smith”. Secondly, insofar as he must have had access to the knowledge widespread in the world’s intelligence community that the Russian foreign intelligence service SVR far surpassed the CIA in its utter sophistication,<sup>6</sup> he must have felt an urge to reduce this “Russian thing” to ashes with the most gibberish garbage and then pick out a few of the nice tricks

therefrom for his own future use when he wanted to secretly stab people in their back: just as he had done with the Chinese intelligence. He would then want to do that to every other intelligence service around the world which was not under his command: he must have been wishing for an “end of intelligence” as we have traditionally known it. This is something you need to know about the neoconservatives: they hated those in the intelligence business because they hated the possession of an intelligent mind, of the ability to distinguish between truth and lies and good and evil, by any human beings outside their circle; they preferred the domination of human beings through machines and the mass deception of humanity by themselves alone. Mr Secretary was of the same bent, save that he would enjoy then and now the mind-boggling tricks which different intelligence agencies possessed here and there: the staging of fake environment in the case of the CIA; the pickpockets, underage operatives, and the smooth talking in the case of the Chinese MSS; and the supreme ability to disguise as Westerners with unidentifiable makeup and to “penetrate” in the case of the Russian SVR, etc.

Let us conclude. Before 2008, human microchipping – with whatever kind, bodily chips or brain chips – was an occasional phenomenon. Aaron Russo, in a 2005 interview with Alex Jones, has revealed that Rockefellers and the ruling elite were planning on implanting RFID chips into every single person: what this means is that Cheney was envisaging universal human microchipping since the beginning of the Bush administration.<sup>7</sup> Microchipping of government officials has also occasionally happened, such as when, for example, in 2004 the Attorney General of Mexico Rafael Macedo openly admitted that he and his staff had been “chipped” to enable them to be located if kidnapped and to grant them exclusive access to computerized databases for crime investigators.<sup>8</sup> By the end of 2008, because of this International Court trial, bodily microchips like those inside the body of Rafael Macedo were becoming standard, in fact a requirement, among government officials around the world, and brain chips began showing up in some portion of the world’s governing elites. Again, Cheney had wanted this in order to control government officials of the whole world to accomplish his agenda.

### THE *DISPOSITIFS* FOR REMOTELY CONTROLLING HUMAN BEINGS

Before we move on, we should have a word about the working of the “special sort” of technology of domination, the nanochip system for remotely controlling human beings. What the commissioner wants is unconditional and idiotic obedience to him, and, given the complexity of the working of the human brain, it’s easier to attain such obedience from someone by making him or her confuse the commissioner’s command as his or her own than to eliminate his or her will to disobey the commissioner’s command. The human being would then have to split into two, one giving command and one obeying the command, but he or she would have to believe that both are just him- or herself. Where do we find an example of such a human being? The misnomer “schizophrenic”: the “split-brain”. The schizophrenic, during times of auditory “command hallucination” and hearing voices in his or her head telling him or her to do something, often does do it, and the will to disobey the Other would not figure in here. At some point, the DARPA researchers would have thought that the American dream of making human beings into remotely controlled robot was indeed possible through an artificially induced schizophrenia if one could only substitute the “voice of controller” for the “real” voices the

schizophrenic was hearing during times of command hallucination. As for the causes of schizophrenia – for a long time the “dopamine hypothesis” is the dominant explanation for the genesis of schizophrenia. It says roughly that, there being three major centers of dopamine production and activation in the brain (“nigrostriatal” in the mid-brain ventral tegmental area accounting for the majority of the human dopaminergic system, the “mesocortical” toward the front, and another “tuberohypophysial”), schizophrenia is caused by the over-production of dopamine in the mid-brain section and the under-production of dopamine in the dopaminergic system in the front. The two systems are supposedly correlated and the former over-production excites, while the latter under-production stupefies, the person. In order to artificially produce in a person the schizophrenic condition of “obeying the voices inside”, a nanochip may be inserted into the mid-brain section of his or her dopaminergic system (the ventral tegmental area) in order to excite the production (or to inhibit the reuptake) of dopamine in that region, resulting also in the deficiency of dopamine in the frontal section. The nanochip is thus something like the reverse of anti-psychotic drug – and the electronic equivalent of agonists such as amphetamine and so on. When the person so chipped was excited in spirit and yet dampened in certain intellectual functions, he or she had formally entered into an artificially induced mode of schizophrenia – or command hallucination to be more exact – and would be ready to obey the “voice of the controller” mimicking auditory hallucinations. Now another neurotransmitter, serotonin, is involved in a schizophrenic’s hallucination episodes, such as his auditory hallucinations. The nanochip may or may not have any effect on the level of serotonin in the brain, but presumably, since the goal was to replace the “real” auditory hallucinations with the “voice of the controller” from the control center, the nanochip would not have encouraged the onset of any actual auditory hallucinations. Another type of nano device needed to be implanted in the target person’s brain, transmitting to him or her the instructions of (say) the US military officer talking to the microphone in the control center far away. The target person would then confuse that voice instruction as his own hallucination and act on it insofar as in spirit he or she has already faded into the mode of a schizophrenic. It would seem that a nanochip system consisted of these two types of chips is enough to render a person into the controller’s remotely controlled robot. In actual practice, during the official’s time in the “Chamber for the Enforcement of Judgments” at the International Court of Justice, the targeted person would have been implanted with additional chips in other parts of his brain for the purpose of remotely reading his thoughts. This “mind-reading” nano brain chips pick up information about the global activity patterns of the target’s brain and send the information back to the computer system in the control center. The software on the computer system translates the information on activity patterns back into thoughts, feelings, visions, etc., by breaking down the patterns detected into elementary components and then matching the elementary components with identical patterns stored in a “mind reading dictionary” (pre-decoded information on human brain activity patterns). In other words, the computer is now reading the targeted person’s thoughts. In this way the controller can see on his computer screen what the target person sees and read what the target person is thinking. The controller will then have no need to install a camera on the targeted person in order to see what he is seeing and where he is moving to. The activity patterns on his visual cortex would have been intercepted into the control center and decoded into images so that the targeted person has in effect become a walking surveillance camera for his controller. All these nano devices use a nano radio device made of carbon nanotube for communication with the computer in the control center. The nano radio is so powerful that, although nano, it operates on frequency up to 100 Ghz and sends signals all the way to satellites. Thus the chips for remotely controlling a person came in a set of three: the chip to artificially induce the schizophrenic state of command hallucination, the chip to transmit voices, and the chip to read the person's thoughts.

This method of remotely controlling people was so superb that no one could tell that the Chinese government officials who had come back from the International Court were no longer themselves but were actually remotely controlled by shadowy American officers from some secret Homeland Security control center. In my encounter with the people under remote control in this way – who were sent in front of me per International Court order, as you shall see – I noticed that many of them, although not all, tended to have red eyes. In later narratives I will offer more description of the nano brain chip systems that would become the focus of this International Court trial. For now I want to note that the “mind-reading” nanochip could itself allow the controller to remotely control the implantee to some extent, but that, when it comes to the person who has been implanted with the mind-reading nanochips only, the controller cannot control him to do anything he wants him to do, but only what it has been natural for him to do, whereas, when it comes to the person who has been implanted with the chips to render him into the state of command hallucination, the controller will be able to control him to do even those things which it has never been his habit to do. For example, the controller cannot control a person who has been implanted with mind-reading nanochips alone to eat shit, whereas he can control the person who has been rendered into the state of command hallucination to eat shit: he would only need to speak to him, “Eat shit”, and the implantee, because he feels compelled to do what the voices he hears is telling him to do, will eat shit accordingly.

If all this sounds too much like impossible science fiction, you should compare it with the earlier versions of mind control technology which have been commissioned by the US government in such project as ARTICHOKE, BLUEBIRD, PANDORA, MKDELTA, MKSEARCH, MKNAOMI, MKACTION, and the infamous MKULTRA. These, especially MKULTRA, have been so rumored about in the counter-culture domain as to arouse no particular reaction. As I have noted, in Volume V, “The conspiracy in the International Criminal Court”, I will present a thorough exposition of the nanochip system for mind-control. Here, for the sake of some background information – to open your mind in case you are not familiar with the discursive world of counter-culture – I shall refer you to a short, nevertheless comprehensive, summary in Martin Cannon's “The Controller: A New Hypothesis of Alien Abduction”.<sup>9</sup> In the context of the older versions of mind-control projects, the *dispositifs* I have described here may justly be considered as the latest, and most successful, making of a “Manchurian Candidate”.

Cannon's concern in this article is to explain the experience of UFO abductees as, in fact, that of subjection to US government agencies' mind control experiments. Some of these experiments are clearly precedents for the *dispositifs* named here for remote control of human beings. The newly-formed CIA started in 1950 with Project BLUEBIRD, rechristened ARTICHOKE in 1951, and renamed MKULTRA in 1953. Through MKULTRA “the Agency created an umbrella program of positively Joycean scope, designed to ferret out all possible means of invading what George Orwell once called ‘the space between our ears’”. What were studied were hypnosis, conditioning, sensory deprivation, drugs, religious cults, microwaves, psychosurgery, brain implants, ESP, and – what we are particularly concerned with here – “psychoelectronics”. Cannon describes “psychoelectronics”:

“Perhaps the most interesting pieces of evidence surrounding the abduction phenomenon are the intracerebral implants allegedly visible in the X-rays and MRI scans of many abductees. Indeed, abductees often describe operations in which needles are inserted into the brain; more frequently

still, they report implantation of foreign objects through the sinus cavities...

“The abductees’ implants strongly suggest a technological lineage which can be traced to a device known as a ‘stimoceiver’, invented in the late 50s – early 60s by a neuroscientist named Jose Delgado. The stimoceiver is a miniature depth electrode which can receive and transmit electronic signals over FM radio waves. By stimulating a correctly-positioned stimoceiver, an outside operator can wield a surprising degree of control over the subject’s responses...

“The most famous example of the stimoceiver in action occurred in a Madrid bull ring. Delgado ‘wired’ the bull before stepping into the ring, entirely unprotected. Furious for gore, the bull charged toward the doctor – then stopped, just before reaching him. The technician-turned-toreador had halted the animal by simply pushing a button on a black box, held in the hand...

“Speaking in 1966... Delgado asserted that his experiments ‘support the distasteful conclusion that motion, emotion, and behavior can be directed by electrical forces and that humans can be controlled like robots by push buttons.’ He even prophesied a day when brain control could be turned over to non-human operators, by establishing two-way radio communication between the implanted brain and a computer...”

Delgado’s predication has unfortunately been confirmed in 2008. Although the *modus operandi* for our latest *dispositifs* – artificially induced command hallucination – is far different than the simple electrical stimulation by which Delgado’s psychoelectronics operated, the aim is the same: to remotely control another sentient being. Moreover, the latest *dispositifs* is commissioned by the US military rather than by the CIA. Clearly, what has happened is that, even after the Agency has ceased research in mind-control technology, the US military has continued to clandestinely pursue it, commissioning research into other *moda operandi*. The device for transmitting controller’s voices to the target also has precedents in Delgado’s experiments:

“In a fascinating series of experiments, Delgado attached the stimoceiver to the tympanic membrane, thereby transforming the ear into a sort of microphone. An assistant would whisper ‘How are you?’ into the ear of a suitably ‘fixed’ cat, and Delgado could hear the words over a loudspeaker in the next room.

“Yet the ramifications of this technology may go even deeper than Marchetti indicates. I presume that if a suitably-wired subject’s inner ear can be made into a microphone, it can also be made into a loudspeaker – one possible explanation for the ‘voices’ heard by abductees.”

I will note later how the technology for remote transmission of voices to a target eventually became widespread in the community of “targeted individuals”, known as “V2K” (Voice-to-Skull). In short, the ideal of a remotely controlled human being who never knows who is controlling him or her has been attained long ago:

“The abductee – or the mind control victim – need not have physical contact with a hypnotist for hypnotic suggestion to take effect; trance could be induced, and suggestions made, via the intracerebral transmitters described above...

“Over the years, certain journalists have asserted that the CIA has mastered a technology called RHIC-EDOM. RHIC means ‘Radio Hypnotic Intracerebral Control.’ EDOM stands for ‘Electronic Dissolution of Memory.’ Together, these techniques can – allegedly – remotely induce hypnotic trance, deliver suggestions to the subject, and erase all memory for both the instruction period and the act which the subject is asked to perform...

“RHIC uses the stimoceiver, or a microminiaturized offspring of that technology to induce a hypnotic state... RHIC-EDOM is described by both Lawrence and Moore as a product of MILITARY research...”

As for mind-reading or remote monitoring of people’s thoughts, it is also not as amazingly impossible as you may think it is. If you have been following the news on the latest advances in neurology, you will find many items reporting the near success in reading people’s thoughts with fMRI technology already in 2006. It is merely the full realization of “brain-computer interface” (BCI). A 2009 episode of “That’s Impossible” on the History Channel, “Mind Control”, also documents thought-reading computer chips and other devices similar to the *dispositifs* I am describing here.<sup>10</sup>

#### THE REMODELING OF THE INTERNATIONAL COURT OF JUSTICE

All the above said, we can thus imagine a complete futuristic remodeling by the Americans of the International Court of Justice as a computerized sado-masochistic dungeon by the end of 2008, by which time the judges there would have been thoroughly fooled like donkeys by Mr Secretary and entirely at his fingertips – something which I have incidentally imagined in my blog post of August 19 2008, as noted (“Lies and fear about the movies”). I kept imagining “Boss” Cheney himself looking over the design plan of the new “Dungeon” in his office one day in the summer of 2008 when he had just been informed of the readiness of that “special sort of technology for domination”. The International Court was the *locus operandi* for his new Plan, so to speak. The origin of this “American remodeling of the International Court” of course dated back to February 2008 when I had just returned to Los Angeles, when this “faulty surveillance Machine” was first installed in the Court house. We can safely assume that, by the end of 2008, the Court room, restructured from a former Homeland Security control center, would look nothing like a court room at all, but would look more like the bridge of the Enterprise in the movie “Star Trek”. Computer screens everywhere, and the faulty surveillance Machine pumping out pages after pages of textual descriptions of the vaguest sort each day for examination. The Court room, when I was in Los Angeles, would be located underneath downtown Los Angeles, somewhere between the Pershing Square and the county Superior Court, as I would later learn in 2010. The microchips under world’s officials’ skin constituted a system of constraints in that they could not simply ignore Court orders and not show up or leave. Furthermore, when they were convicted, they could not disobey the order for them to be transported into the “Chamber for the Enforcement of Judgments” to receive “treatment”. In other words, when the judges issued a judgment, the judgment was automatically input into the super computer with which all the microchips inside the bodies of the elites were interfaced, just as when the United Nations Assembly or Security Council passed a certain resolution, it was automatically input into the super computer. It was a frightening picture, a horrifying mechanism of “justice” from which there was no escape. When the Chinese, and

then the Russian, officials were first led into the “court room” in the latter half of 2008, each of them must have been completely shocked: “What have the Americans done to the International Court of Justice? Everything looks more like science fiction than what you would think a traditional court house should look like...” The good old days of national sovereignty, when nations could freely ignore International Court orders or UN Resolutions, were gone, thanks to “Boss” Cheney.

### THE NEW CHENEY PLAN

Now four months or so after my “exile” from Karin's meetups, it would appear as if the Democrats were back in office again and as if the neoconservatives had packed up their bags and gone home to enjoy their retirement. But all that was appearance only. In reality, Cheney’s project of a totalitarian utopia had just come one step closer to definitive fruition when the US administration switched back to the Democrats in January 2009. Cheney had a plan for humanity in response to the crisis of human civilization when oil should run out, and so did the rest of the industrial and political elites of the Western world. It will not be discussed here, but will be discussed in the Preface of Volume V, how the ruling elites in the West were divided between a moderate camp and a radical camp, how Boss Cheney belonged to the radical camp, and how these two camps had different plans in response to the crisis of human civilization and were in conflict with each other. The moderate camp was represented by the “Bilderberg majority”, and by the end of 2008, it all seemed that Cheney was willing to give in to the Moderates and give up his radical version of the Plan (*his* utopia). But, having made the preparatory steps which we have just described, Cheney had decided to secretly continue his plan. The Bilderberg majority had hand-picked Obama and Hilary Clinton to succeed Cheney’s administration in order to continue their moderate version of the Plan. What the Big Boss had done was simply retreat into the background, allow the Moderates to manipulate the 2008 election so as to create the semblance that he had given up and that the Democrats, per people's wish, had come back to office, and then, once the newly elected Democrats were in place by February 2009, dupe them to some secret places so as to “chip” them all in their brain. The “Boss” would thus become the hidden Master Puppeteers of the Democratic party. The moderate “Bilderberg majority” had apparently decided that the first African American president, rather than the first white female president, would be their man to carry out their plan: for the rest of the world would respond much more favorably to an African American president and look upon a United States led by a black man as the light of goodness while only American white women would respond favorably to a first white female president. America is definitely a land of equality and justice, the rest of the world would shout, where even a black man can become the president. The Moderates thought that they could thereby fix the bad reputation which the United States had incurred during Cheney’s reign. What they did not know was that our Big Boss would cut in to render the African American president and the new Secretary of State and other key Democrats his remotely controlled robots so that, while the world had recovered its faith in United States as the beacon of goodness after the neoconservative imperialism had done so much to dispel such faith, he and his cliques could continue orchestrating domestic and world affairs in such a way that his new, changed plan for the establishment of a *Weltstaadt* could eventually come into being, all as if due to the actions of other “bad nations”, like Russia and China, and to the unwise policies of a stupid American president. At the same time, his project of the “universal chipping of all humanity” would be making headway in increasing momentum as health care companies. etc., under his planning, started finding all sorts of humanitarian pretexts to implant chips in an increasing number of common people, not just in the United States, but all around the planet.

“Denn alles, was entsteht  
Ist wert,  
dass es zugrunde geht...  
So ist dann alles,  
was Ihr Sünde, Zerstörung, kurz  
das Böse nennt,  
Meine eigentliches Element...”  
(Goethe’s Mephistopheles  
and the deep truth about the neocons)

Now it was when Russia repelled Georgia’s invasion of South Ossetia that the Boss had decided to use the same method he had had success with the Chinese, namely, of implanting chips into Russian elites’ brains through the International Court system as a way to remotely control them to play out his script of World War Three – of which he was still dreaming. Thus people started speaking Russian and Hungarian next to me in Karin’s meetup on September 3 2008 in front of the Corner Bakery. Cheney’s original dream of depopulating the planet earth through a nuclear holocaust was suddenly so much closer to him. Mr Secretary seems to have had a great deal of difficulty in framing the Chinese military for conspiracy with me, and, that aside, China possessed only two dozen ICBMs along with only one functional strategic submarine that was armed with ballistic missiles with nuclear war heads. Now this was Cheney’s new plan: if only he could succeed in getting his schizophrenia-inducing chips into Russian elites’ heads – he could do this if his darling Mr Secretary Chertoff could convict them of participating in the same conspiracy to send David Chin to pretend to be Lawrence Chin – then he could simply *orchestrate* the nuclear holocaust which he was originally planning on *bringing into being through provocation*: since he could no longer create nuclear destruction at home and blame it on the “terrorists” hiding in Iran, he would remotely control Obama to do other things which would cause the Russians to be unjustly provoked, and then remotely control the Russian elites – including Putin, all having been rendered “schizophrenic” through the International Court – to fire nuclear missiles on American targets etc., which could then start the nuclear holocaust that would vastly reduce the number of human beings on the planet in accordance with the PLAN. It’s all the better because the nuclear holocaust would be blamed entirely on Russia and partly on the stunted Obama – no one will ever know that it was all Cheney’s work. Another advantage of this modified PLAN was that the scale and domain of the nuclear holocaust could then be carefully controlled and calibrated to fit the “post-holocaust reconstruction” which Cheney had in mind. In fact, Cheney would have another super computer set up to automatically coordinate the actions of all the remotely controlled Chinese, Russian, and American elites as a way to direct them to play out a script of World War Three which he would have personally written and fed into the computer and which would dictate the outcome that the United States should emerge triumphant from the nuclear war. Cheney was envisaging the orchestration of international and domestic politics in such fashion that, when ordinary people see international politics etc., on TV news (such as when the head of one state shakes the hand of the head of another state to broker a deal or when one declares war on another), all that has in fact happened is just a puppet show orchestrated by his secret cadre of elites from some secret control center where they would be remotely controlling these heads of states to put up a show as a way to deceive ordinary people into thinking that all this is real or “natural”. Between September 2008 and February 2009, then, a conference must have been convened in which Cheney’s gang and selected members of the Western alliance showed each other all sorts of charts denoting the number of people and the amount of resources around the globe and discussed the number of human beings that would have to be killed and where so that the

remaining human beings could be adjusted proportionally to the resources that were still existent. It’s likely that their “calculation” might have convinced them to wipe out, “for the good of humanity”, as many as six billion out of the seven billion human beings on the planet. Of course such conference would easily remind you of the Wannsee conference in January 1942 where the “Final Solution” was decided, but apparently the participants in this conference were sufficiently convinced by their “historic mission” – or by the fear of being left out of the cliques of the upcoming elites and thus suffering bad fate – to not think of the strange parallel. Who were the participants? I would guess that, other than the “Boss”, Mr Secretary, and the other typical neocons, a few from the European governments who had defected to Cheney’s side from the Bilderberg majority, the then Polish president, a few high-ranking officers from the CIA who were now Cheney’s slaves, and many members from the “military-industrial complexes” and big corporations in the United States. It would be left to Mr Secretary to spearhead these people into the secret governing elites of the upcoming, post-holocaust, utopian *Weltstaadt*.

In the coming narrative I will get into some of the details of the “new Cheney Plan” (notably in the Preface to Volume V). Suffice it to emphasize here that everything which I have described Boss Cheney had done and was planning to do was *legal*, namely, sanctioned by Madam President of the International Court of Justice judge Higgins as proper compensation to the United States under UN Resolution 1373. When, a year later, in late 2009, when United States was caught planning this genocide through the International Court system, Cheney, Chertoff, and the CIA simply revealed that judge Higgins had ruled that the proper enforcement of UN Resolution 1373 meant that United States should be allowed to restructure international relations and dominate the world – and United States had decided the way in which it would dominate the world was through puppeteering Russian and Chinese elites to fight World War Three with nuclear bombs – and when the world pointed out that everyone was misled as to the real function of the nanochips implanted in the brain of Chinese and Russian officials convicted of sending David Chin to pretend to be Lawrence Chin, the United States would simply counter again that it was precisely through concealing from everyone the fact that the principal nations’ elites had all been rendered Americans’ remotely controlled robots that US domination of the world, sanctioned by the highest compartment of the International Court of Justice, could be most effectively achieved. Our Boss Cheney was planning on genocide that was permitted under international laws! He couldn’t even be prosecuted for crimes against humanity! All because, originally, when the MSS director sued the United States, he was hoping for nothing less than dethroning the United States and replacing it with China as the new leader in international relations.

### AMERICA AS THE “OPPOSITE LAND”

The dispositif for the remote control of human beings fit well in general America’s, and in particular neoconservatives’ *modus operandi* in the re-transvaluation of values – sanity is bad but could be cured by being inverted into schizophrenia which would then be good. Ever since the neoconservatives seized the governing apparatus of the United States in 2001, they had begun a conscious effort to destroy the former transparency of the governing process just as they had made a conscious effort in centralizing the governmental apparatus and knocking down the decentralized federal system which had hitherto constituted the United States’ governmental style, from the local county government all the way to the federal government. But the aim here was to hide the *real* government behind a veil of secrecy while pretending on the surface to continue the former practice of transparency. This has resulted, as I have noted, in a layering of the reality in regard to the governmental process, that on the surface the government made people believe it was doing this while it was actually doing something else on the

deeper level of reality to which only the elites had access. Citizens would continue to believe that the governmental process was open for common knowledge, not knowing that the common knowledge had been transformed into a veil to cover up, and distract attention from, a newly constituted shadow government hidden in utter secrecy. This technique works so much more effectively than, say, the Chinese government's typical way to hide its process from its people, namely, simply silence on all matters.

As noted in the Preface, the neoconservatives take seriously the Nietzschean transvaluation of all values, and their transvaluation operates within this framework of the two tier reality, the surface level of reality, or rather illusions, given to the masses to live in and a "deep reality" beneath, the "true reality", to which only the elites should have access. Between these two tiers, however, values and realities would be inverted: who is the truth-teller in the deep reality would appear as the liar on the surface layer of reality and who is the liar in the deep reality would figure as the truth-teller on the surface layer of reality; what is good and sane in the deep reality would have to be made into evil and insane on the surface layer of reality and what is evil and insane in the deep reality would have to be known as good and sane on the surface layer of reality. In a way this was not invented by the neocons but had already become the modus operandi of American politics starting from the Clinton era, and was intensified under the Bush administration. With this modus operandi American foreign policy begins to acquire a pernicious air of hypocrisy which only its victim would notice. Under Cheney's remote control, the Obama administration has continued the trend. To take as an example the ousting of Honduras' president Manuel Zelaya in late June 2009. The Nicaraguan Foreign Minister Samuel Santos was certainly correct in naming the coup as a US orchestration,<sup>11</sup> but then the remotely controlled US president would go to Russia and utter the hypocrisy that, although the United States had been having problems with the ousted president of Honduras, it would support his return simply because it always supported democratically elected leaders. Ordinary people who did not know about the "bad things" which the US would do under the table to undermine anyone not agreeing with it, democratically elected or not, would really be impressed by this great beacon of goodness which this country *appears* to be. But it's all a show. In deep reality, the United States cares not about championing democracy, but only about who would be its friends – in fact, it cares about the exact opposite: as you shall see, under Cheney, the mission of the United States in the world is to eliminate all imaginable forms of freedom and liberty while preventing anyone from realizing this. (Cheney has even more advanced from "smart totalitarianism".) This is how it works: what US believes at bottom is always turned into what it doesn't believe on the surface and what it doesn't believe at bottom is always turned into what it does believe on the surface.

Now our Secretary of Homeland Security Department was hardly an educated mind which could understand Nietzsche's transvaluation of values, but, as the foregoing narrative of my struggles with him has been meant to show, he had made into the very axis of his self-esteem such ability to deceive people into believing to be true the opposite of what was really true. While in deep reality it is I who have written my story "My experience with the FBI, CIA, and DHS..." and drawn and painted my artworks and it is the fake Lawrence who has stolen these from me, the judges of the ICJ and the rest of the world subsisting on the surface layer of reality must be duped into believing that it is the fake Lawrence who has written the essay and drawn and painted the artworks while I have merely stolen these from him; while in deep reality the elites (Mr Secretary's clique) know that I am the real

Lawrence and am truth-telling, sane, and high functioning in intellect, the masses, world’s government officials, and the ICJ judges stuck on the surface layer of reality must believe that I am the fake Lawrence, lying, pretending, and schizophrenic, while taking him who in deep reality is the fake Lawrence to be the real Lawrence on this surface layer of reality. While the elites who have access to the deep reality know that it is Wes who has tried to victimize me by pressing the buttons on the keypad on his phone, the judges and the rest of the world must believe, according to the inverted reality on the surface to which they are bound, that it is I who have tried to victimize Wes by manipulating strange audio software to forge his voice. While all the elites know in deep reality that it is Mr Secretary who has routed my Skype call to Taiwan, the rest of the world, stuck on the surface layer of reality, would need to believe that it is the director of the MSS and I who have played a prank to frame Mr Secretary into looking like he has committed perjury. While the few elites with access to deep reality know that it is Mr Secretary who has intentionally lied to the Chinese, the rest of the inferior humankind, with access only to the surface layer of reality, would have to believe that it is the Chinese who have intentionally “forged me” in order to entrap Mr Secretary and make his honest and correct information look like lies. Because Mr Secretary suffered from Antisocial Personality Disorder and was a natural born criminal, he took a very personal, and deep, delight in this neoconservative, and American, process of the inversion of reality and values between the two tiers of reality, while other neoconservatives were driven to such purest form of evil more by the spirit of revolutionary radicalism, a Straussian nihilism, and a reactionary pessimism engendered by the trauma of the Holocaust. I call Mr Secretary here the “Opposite Man” (*homo contrariis*), he who believes that the good should be known as the bad and the bad as the good, and that the guilty as the innocent and the innocent as the guilty. The process of Mr Secretary’s lies bears in fact a close resemblance to the process of myths such as described by Lévi-Strauss in his *Mythologiques*, where the next episode in the myth is typically engendered by the inversion of the elements of the previous episode of the myth.<sup>12</sup>

The hero's mother ordered the girl to make the beverage from a pile of maize, but then accused her wrongly of laziness when she was able to make five jars of the beverage from merely one ear. She left, after telling the hero to join her and her people by going downstream on a pirogue. He went with his brother-in-law, and both of them turned into birds just when the pirogue stood up perpendicularly on the waters: one perching on one shoulder of the *ara* girl and the other on the other shoulder of hers. As his fifth wife, the hero marries a girl of the same lineage as he. The girl would separate in two, the lower body remaining by the bank and the upper body going into the waters to fish. After fishing, the upper body would come up shore and reunite with the lower body. One day, however, the hero's mother came to the river and took away the girl's lower body. The upper body ascended to a tree and then came down to perch on the hero's shoulder when he passed by, preventing him from eating and then defecating all over his neck. The hero played a trick to persuade his wife's upper body from leaving him, by going into the water and warning her that fish would dig out her eyes. The wife's upper body then transformed into a parrot and flew away.

The binary opposition which constitutes the structure of the myth on the most general level is that between endogamy and exogamy: the first four marriages are exogamous, between man and a female of an animal species, while the fifth marriage is between the hero and a woman of his own people. “The fourth episode, relative to an exogamous marriage like the preceding ones, but constructed exactly like the following one, forms the pivot of a narrative which possesses from this fact a double structure, at the same time binary and tertiary” (p. 21):

But Mr Secretary and his neoconservative order of things are in fact just special instances of the typical American way. Unbeknownst to humanity around the world, the “American way” has been precisely to make the bad look good, the good look bad, the victim look like the victimizer, the victimizer look like the victim, the genius look insane, and the ordinary stupid people living in delusions look “normal”.

Among the exogamous marriages, Lévi-Strauss notes that “they occur, in order, with four animals which are alternatively 'of low' [*d'en bas*] (since they live underground [*dans des terriers*]) and 'of high' (these are then the birds)” (ibid): 1: toad; 2: the bird *arapaço*; 3: earth worm; 4: the bird *ara*. As one can see, the second element is engendered by inverting the first, the third by inverting the second, and the fourth by inverting the third. Furthermore, the roles of the four animals are in a system of oppositions in the following manner:

The first opposition has just been discussed. When the *arapaço* is engendered through the inversion of the toad, it merely perches on trees, but when *ara* is engendered from the inversion of the worm it flies in the air. The toad, hiding in its hole, is also “lower” than the worm which pops out of its hole. The structure of the second pair of animals is therefore engendered through an inversion of the structure of the first pair. The toad does not move while the hero urinates, but the worm pops out when he defecates. The second pair of animals are thus mobile in contrast to the immobility of the first pair, and the pair is engendered by the inversion of the first pair. The pirogue in the fourth episode moves, while the tree (post) on which the upper half of the fifth wife perches is immobile. The latter is thus engendered through the inversion of the former.

Lévi-Strauss then isolates a third system of oppositions from among the first four episodes:

	raw:	cooked:	
excretion:	(1) urine	(3) feces	(from man to woman)
nutrition:	(2) sap	(4) beer	(from woman to man)

The second episode of the hero's receiving the sap of palm trees is engendered through the inversion of the first episode where he urinates into the hole, just as the fourth episode of his receiving the beer of maize is engendered through the inversion of the third episode where he defecates over the hole: excretion is inverted into nutrition. Meanwhile, the second pair of narratives is engendered through the inversion of the first pair in that all that appears raw will be inverted into what looks or is cooked.

Lévi-Strauss is at pain to emphasize that this myth, though appearing linear and open to indefinite extension of the same sort, is developed simultaneously on several planes (p. 26) and nicely rounded off into a closed structure with the fifth episode, into which we need not continue to make our point. **The neoconservative, Mr Secretary’s, and America’s universe has essentially the same structure as does a primitive myth: there should be two layers to reality which are opposite to each other: the deep reality – accessible to only a few – is the opposite of the surface reality – accessible to everyone – and truth – which makes up the content of the deep layer – is the opposite of falsehood and illusions – which make up the content of the surface layer of reality. Every element in the content of the surface layer of reality is created through the inversion of the corresponding element in the deep layer of reality.**

This “American way” will become increasingly the theme in the narratives to come. In observing the American society I often think of Ludvig von Holberg’s *Nicolai Klimii iter subterraneum* (where in one province, Cocklecu, of the reverse of utopia, Potu, women rule and men stay home, and where in another the queer French society is described as an anomaly)<sup>13</sup> or a French movie I have seen (whose title I no longer remember) in which reality is inverted, such that people convene around the table to sit on toilets but retreat each to a single room alone to have a meal.

One more thing about the neoconservative difference. In the neoconservative, and hence in Mr Secretary’s, scheme of things, the CIA’s clandestine service really represents an inconvenience which shouldn’t have existed. In the former’s worldview, there are but the elites, who are the Jewish-led neoconservatives themselves, dwelling on the deep layer of reality, and the commoners who should be as stupid and as gullible as peasants, dwelling on the surface layer of illusions. There is simply no place in such worldview for academics and intellectuals who can see through to the deep reality and yet who are not part of the ruling elites. The case for me is even worse. I should have been an excommunicate of the commoners and therefore should have had access to neither the deep reality nor the surface layer of illusions, namely, all the lies produced about me. And yet I know the truth about myself. The best way to keep my status as an excommunicate, in Mr Secretary’s scheme of things, therefore, would be to maintain me as a dummy who doesn’t even know that lies or illusions have been produced about him at all. I must be conquered. In the same regard, one night in March 2008 or so, when I was going to the coffee place Psychobabble on Vermont near Hollywood, Mr Secretary tried for the last time the technique he had learned from the Agency, evacuating the place before I entered and then filling it up with his actors and actresses pretending to be employees and patrons. When I walked in, I did notice that the whole establishment was a fake because the vulgarity of the Homeland Security operatives simply couldn’t pass unnoticed. But I said nothing and just went upstairs to work on my learning of C++. I had to dupe Mr Secretary into believing that he had duped me. I shall end this second volume of *The Secret History of the International Court of Justice* with a few more verses from the *Iliad*:

### **APPENDIX III: The text of UNSC Resolution 1373**

At the end of my story of the conviction of China in the International Court of Justice I shall append the actual text of UNSC Resolution 1373. The provisions relevant to my case in this all-important Resolution I shall mark in bold and then specify in brackets how exactly the provisions in question were interpreted by either sides (the MSS director or the CIA/State Department) to accomplish the respective goals they aimed at:

*The Security Council,*

*Reaffirming* its resolutions 1269 (1999) of 19 October 1999 and 1368 (2001) of 12 September 2001, *Reaffirming also* its unequivocal condemnation of the terrorist attacks which took place in New York, Washington, D.C. and Pennsylvania on 11 September 2001, and expressing its determination to prevent all such acts,

*Reaffirming further* that such acts, like any act of international terrorism, constitute a threat to international peace and security,

*Reaffirming* the inherent right of individual or collective self-defence as recognized by the Charter of the United Nations as reiterated in resolution 1368 (2001),

*Reaffirming* the need to combat by all means, in accordance with the Charter of the United Nations, threats to international peace and security caused by terrorist acts,

*Deeply concerned* by the increase, in various regions of the world, of acts of terrorism motivated by intolerance or extremism,

***Calling on States to work together urgently to prevent and suppress terrorist acts***, including through increased cooperation and full implementation of the relevant international conventions relating to terrorism [*from this the CIA lawyers were able to argue that the spirit of the law in this case was that the nations must work together to neutralize the threat which any terrorist may pose to any nation-state member of the international community*],

*Recognizing* the need for States to complement international cooperation by taking additional measures **to prevent and suppress, in their territories through all lawful means**, the financing and preparation

of any acts of terrorism [*the Chinese government was thus obliged to forge evidences, insofar as it was customary in China for the authority to forge evidences in cases where individuals posed a threat to the state, to help United States neutralize the threat I posed to the United States*]

Reaffirming the principle established by the General Assembly in its declaration of October 1970 (resolution 2625 (XXV)) and reiterated by the Security Council in its resolution 1189 (1998) of 13 August 1998, namely that **every State has the duty to refrain from organizing, instigating, assisting or participating in terrorist acts in another State or acquiescing in organized activities within its territory directed towards the commission of such acts** [*United States’ support of Islamic terrorists in Central Asia thus constituted grounds on which to be classed as a “terrorism-sponsoring state”, and the same with MSS director’s support of my act to harm the United States before I flew to China*],

Acting under Chapter VII of the Charter of the United Nations,

1. *Decides* that all States shall:

(a) Prevent and suppress the financing of terrorist acts;

(b) Criminalize the wilful provision or collection, by any means, directly or indirectly, of funds by their nationals or in their territories with the intention that the funds should be used, or in the knowledge that they are to be used, in order to carry out terrorist acts;

(c) Freeze without delay funds and other financial assets or economic resources of persons who commit, or attempt to commit, terrorist acts or participate in or facilitate the commission of terrorist acts; of entities owned or controlled directly or indirectly by such persons; and of persons and entities acting on behalf of, or at the direction of such persons and entities, including funds derived or generated from property owned or controlled directly or indirectly by such persons and associated persons and entities;

(d) Prohibit their nationals or any persons and entities within their territories from making any funds, financial assets or economic resources or financial or other related services available, directly or indirectly, for the benefit of persons who commit or attempt to commit or facilitate or participate in the commission of terrorist acts, of entities owned or controlled, directly or indirectly, by such persons and of persons and entities acting on behalf of or at the direction of such persons;

2. *Decides also* that all States shall:

(a) **Refrain from providing any form of support, active or passive, to entities or persons involved in terrorist acts**, including by suppressing recruitment of members of terrorist groups and eliminating the supply of weapons to terrorists [*The Chinese government thus must refrain from supporting its own spy chief, who intended to conspire with me, to sue the United States*];

(b) **Take the necessary steps to prevent the commission of terrorist acts, including by provision of early warning to other States by exchange of information** [*The Chinese government must neutralize the acts of its own spy chief; and the United States must share information to China about the terrorist suspect, me*];

(c) **Deny safe haven to those who finance, plan, support, or commit terrorist acts, or provide safe havens** [*China thus cannot accept my defection*];

(d) **Prevent those who finance, plan, facilitate or commit terrorist acts from using their respective territories for those purposes against other States or their citizens** [*Again, China must deny my use of flight to China to harm the United States*];

(e) Ensure that any person who participates in the financing, planning, preparation or perpetration of terrorist acts or in supporting terrorist acts is brought to justice and ensure that, in addition to any other measures against them, such terrorist acts are established as serious criminal offences in domestic laws and regulations and that the punishment duly reflects the seriousness of such terrorist acts;

(f) Afford one another the greatest measure of assistance in connection with criminal investigations or criminal proceedings relating to the financing or support of terrorist acts, including assistance in obtaining evidence in their possession necessary for the proceedings;

(g) Prevent the movement of terrorists or terrorist groups by effective border controls and controls on issuance of identity papers and travel documents, and through measures for preventing counterfeiting, forgery or fraudulent use of identity papers and travel documents;

3. *Calls* upon all States to:

(a) Find ways of **intensifying and accelerating the exchange of operational information**, especially regarding actions or movements of terrorist persons or networks; forged or falsified travel documents; traffic in arms, explosives or sensitive materials; use of communications technologies by terrorist groups; and the threat posed by the possession of weapons of mass destruction by terrorist groups;

(b) **Exchange information in accordance with international and domestic law and cooperate on administrative and judicial matters to prevent the commission of terrorist acts**;

(c) **Cooperate, particularly through bilateral and multilateral arrangements and agreements, to prevent and suppress terrorist attacks and take action against perpetrators of such acts**;

(d) Become parties as soon as possible to the relevant international conventions and protocols relating to terrorism, including the International Convention for the Suppression of the Financing of Terrorism of 9 December 1999;

(e) Increase cooperation and fully implement the relevant international conventions and protocols relating to terrorism and Security Council resolutions 1269 (1999) and 1368 (2001);

(f) Take appropriate measures in conformity with the relevant provisions of national and international law, **including international standards of human rights**, before granting refugee status, for the purpose of ensuring that the asylum-seeker has not planned, facilitated or participated in the commission of terrorist acts [*hence judge Higgins' concern for me after the sting operation of 31 December 2007*];

(g) Ensure, in conformity with international law, that refugee status is not abused by the perpetrators, organizers or facilitators of terrorist acts, and that claims of political motivation are not recognized as grounds for refusing requests for the extradition of alleged terrorists;

4. *Notes* with concern the close connection between international terrorism and transnational organized crime, illicit drugs, money-laundering, illegal arms trafficking, and illegal movement of nuclear, chemical, biological and other potentially deadly materials, and in this regard *emphasizes* the need to enhance coordination of efforts on national, sub-regional, regional and international levels in order to strengthen a global response to this serious challenge and threat to international security;

5. *Declares* that acts, methods, and practices of terrorism are contrary to the purposes and principles of the United Nations and that knowingly financing, planning and inciting terrorist acts are also contrary to the purposes and principles of the United Nations;

6. *Decides* to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council, consisting of all the members of the Council, to monitor implementation of this resolution, with the assistance of appropriate expertise, and *calls upon* all States to report to the Committee, no later than 90 days from the date of adoption of this resolution and thereafter according to a timetable to be proposed by the Committee, on the steps they have taken to implement this resolution [*the origin of the Counter-Terrorism Committee, CTC*];

7. *Directs* the Committee to delineate its tasks, submit a work programme within 30 days of the adoption of this resolution, and to consider the support it requires, in consultation with the Secretary-General;

8. *Expresses* its determination to take all necessary steps in order to ensure the full implementation of this resolution, in accordance with its responsibilities under the Charter;

9. *Decides* to remain seized of this matter.
